Following acceptance at the Annual General Meeting, each Friends group's yearly membership fee will be as follows:

Full Member Groups: \$10.00 per year

Affiliated Groups: \$15.00 per year

Individual Member: \$10.00 per year.

This is due by 1 January 2008.

I invite your group to renew its membership. *Under the Constitution, it is compulsory* for every group to pay a membership fee to belong to Friends of Parks Inc. This is because the Constitution provides for the groups to be the members of Friends of Parks Inc. The individual people become members of those 141 member groups.

If any group does not pay its membership fee, it will not be covered by the Constitution, the insurance arrangements, be eligible to apply for grants, or other aspects of our group scheme of Friends.

Your fee for 2008 would be welcomed now. Your group may care to pay two or more years at a time. As your own members need to pay a fee to belong to your group, your group needs to pay a fee to belong to Friends of Parks Inc.

Please pay by 1 January, so that it is up to date with membership before the 2008 Annual General Meeting, which will be held sometime in May, 2008.

If your group has not paid yet for this or last year or more, you may need to check with me to see how much is owed.
